OFFICIAL RULES BRISTOL MOTOR SPEEDWAY

"You Can't Fake Fun at Bristol"

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. OPEN ONLY TO LEGAL U.S. RESIDENTS AND RESIDENTS OF CANADA (EXCLUDING QUEBEC) 18 YEARS OR OLDER AT TIME OF ENTRY. VOID WHERE PROHIBITED OR RESTRICTED.

- 1. Eligibility: Bristol Motor Speedway's "You Can't Fake Fun at Bristol" (the "Promotion") is open only to legal residents of the United States and Canada (excluding Quebec), who are at least eighteen (18) years old at the time of entry. - **3. How to Enter:** Register online at www.bristolmotorspeedway.com by completing a questionnaire. Canadian entrants will be required to complete a skills test if selected as a potential winner. All entries must be received by 11:59:59 p.m. ET March 24, 2019. Single entry is eligible for all prizes.
- **4. Sweepstakes Drawing:** Sponsor will utilize an electronic random selection program to determine potential prize winners. Sponsor's decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion. Sponsor will randomly select winners from all eligible entries on March, 26 2019. All entries will be considered eligible from the day of entry through the duration of the contest.
