DRESS CODE

Casual dress is appropriate for suite level. This includes appropriate length shorts, jeans, polos, tshirts, khakis, etc. Swimsuits, athletic shorts, tshirts with inappropriate language will not be allowed. Shirts and shoes must be worn at all times.



REMINDERS

SUITE CREDENTIALS

Please remember that everyone (including infants & children) must have a digital suite ticket in order to access suite level. Please make sure all of your guests are aware of this policy prior to arriving at the Speedway. All hard cards must have a BMS issued suite access sticker.

SUITE IMPROVEMENTS

Suite holders are responsible for any extra decorating in the suite including walls, ceiling and floor coverings. BMS cannot provide extra stools, tables, chairs, etc. No alterations may be made to the outside walls in the suite hallways. All improvements must be completed one week prior to the event.

SMOKING POLICY

In accordance with Tennessee state law, all suites, grandstands, terraces, and restrooms at Bristol Motor Speedway and Dragway became non-smoking effective October 1, 2007. The general assembly of the state of Tennessee passed the "non-smoker protection act" and governor Phil Bredesen signed it into law. The act prohibits smoking in most public facilities including sports arenas. Guests - including suite guests - must limit smoking activities to our concourse area. Suites, grandstands & terraces, along with restrooms and suite hallways will be non-smoking.

BAG POLICY

A maximum of two bags per person are permitted through the admission gates, not to exceed 18" x 18" x 14" size. Coolers are not permitted on suite level.

FAQ

Will printed suite tickets be available for the Race Weekend?

*No, all tickets will be issued as a **digital ticket** that can be accessed through the Bristol Motor Speedway app. Please access your tickets in advance and have them ready upon approaching the gate. Screenshots cannot be scanned at the gate, you must have the original digital ticket.*

Why haven't I received my digital tickets?

Payment, in full, and a current Certificate of Insurance must be on file to receive your digital tickets. Please refer to the sample COI in this packet.

Will my suite be pre-cleaned in advance?

Yes, inclusive of all elevators that access suite level.

What gates and elevator towers will be open to access suite level?

*All patrons attending the race events will enter the facility through **Gates 6, 10 & 18(Thursday) and Gates 7, 10 & 19 (Friday & Saturday).***

Will I be able to enter my suite early on race day to prepare?

*Yes, suiteholders may access suites **one (1) hour** prior to gate opening times with a digital worker pass. Please let your Business Development Executive know if your desire to enter your suite prior to opening.*

Will I be able to leave & re-enter the stadium?

*Yes, you will be allowed re-entry. Please be sure an attendant **scans your ticket OUT** so it may be scanned back **IN** upon your return.*

Where is Lost & Found?

Where are ATMS?

There is only one ATM in service on the property, It is located in the Fan Zone by the Marquee sign. This is a cashless venue for tickets, concessions and souvenirs. Debit/Credit Cards will be accepted.

Where can we buy souvenirs?

Souvenir stands are located throughout the concourse level. Souvenir Trailers will be located in the (Fan Zone) near the Marquee sign and Blue Bridge.



FAQ

Can I visit concessions and take food back to my suite?

No, guests can not carry food from concourse level to suite level. Guests also cannot carry outside food or beverage in the gate and to their suite.

Will Suite Registration & Services be open?

Yes. Suite Registration will be open on the concourse inside the gates for mobile ticket check-in. Once you are scanned on your mobile device at the gate, please proceed to Suite Registration check-in booth to receive a wristband for suite access. Suite Service Desks on each suite level will also be staffed for any questions.

When will suites close?

*Suites will close **one hour after the checkered flag**. Bar service will stop at the checkered flag.*

What transportation will be provided on property?

Golf cart transportation, including ADA assistance golf carts, will be operating for spectators. Bus shuttles and trams will also be operating for this event.

Where are my suite parking passes?

*Suite clients will receive **paper parking passes** mailed in advance of the event.*

Will there be a Track Walk?

A Track Walk will be conducted on Saturday, September 13th prior to the Bass Pro Shops Night Race from 3:00 pm - 5:00 pm. All suite holders are provided digital track walk passes for 100% of their suite guests. Please leave your suite no later than 4:30 PM and enter at the start/finish line. Be sure to check out the self-guided audio tour by scanning the QR codes stationed along the route!

Where can my guests smoke during the race?

Smoking is not permitted in the grandstands, terrace, suites, garage/infield or restroom areas. Smoking is only permitted in all open concourse and mezzanine areas.

Where can I receive medical attention if necessary?

There are several Ballad Health Fan Care locations open on the property during race weekend. These include: inside Gate 7/Yarbrough A, Allison F, Waltrip P (Lower Level) and roamers on Suite Level. Please visit a suite desk if you need assistance.

PARKING

A parking permit is required for entry to the property from Thursday, September 11 through Saturday, September 13.

- Parking lots will open at 11:00 AM on Thursday and 12:00 PM (Noon) on Friday and Saturday.*
- For directions to your designated lot entrance, scan the WAZE QR code located on the back of your parking pass.*

Post-Event Traffic Notice:

To ensure pedestrian safety, all parking lots will be held for up to one hour following the event. Once it is deemed safe for vehicles to exit, the lots will be released in an orderly manner.



TRACK WALK

All suiteholders will receive digital Track Walk passes for 100% of their guests. This is an opportunity for a self-guided tour on the track prior to the start of the NASCAR Cup Series event. A few important things to note:

- *Pre-Race Track Walk participant can be under 18 years old.*
- *Shorts and open-toed shoes are allowed on track walk.*

If you wish to participate, locate your digital Pre-Race Track Walk pass in your Bristol mobile app and walk down to the start/finish line. It is located under the flagstand on the frontstretch.

Guests will enter the track at the start/finish line and walk around the half-mile oval exiting out the backstretch. You will have access to the racing surface up to the wall on pit road on the frontstretch, through Turns 1 & 2 and down the backstretch. Upon completion of the track walk, return to the suite level by using the elevators under the grandstands.

*The Pre-Race Track Walk is only open from **3:00 pm - 5:00 pm**. Please do not leave the suite after 4:30 pm, as officials will be closing the gate promptly in preparation for pre-race ceremonies.*

TIMES FOR TRACK WALK ARE SUBJECT TO CHANGE DUE TO WEATHER CONDITIONS AND NASCAR DISCRETION.

Please be advised that this could be strenuous for some people with health conditions. The embankment is quite steep and therefore guests are not allowed to climb to the outside track wall.
